Kratek predmeta razpisa:	<p>The aim of this action is to promote and teach Science, Engineering, Technology and Maths subjects (STEM) to girls in attractive and engaging ways, with a view to addressing the ongoing skills gap in the STEM sectors within the EU and especially the shortfall of women & increasing STEM drop-out rates of girls.</p> <p>The underlying rationale is also to empower girls to learn and encourage them to become leaders in tech.</p> <p>This aim is going to be achieved through a two-fold action.</p> <p>Firstly, a network of schools, universities, high education institutions and companies will be set up.
